

Terms of Consignment

Consignment is - first by calling – 703-938-8800 to set up a time. NO fee is charged to open an account. Unless with prior agreement, please limit to 10 items per consignment appointment. With jewelry there is no limit. If you have any special requests, questions, please call BEFORE bringing items in. We do not consign shoes.

1. PRICING AND TERMS OF SALE:

- Articles will be priced by JUST LIKE NEW with the input of the consignor.
- Consignor will receive fifty percent (50%) of **final sold price**. For items that are sold over \$1,000.00 each (e.g - Jewelry, Fine Crystal, China, Silver or Artwork), the percentage split will be 60% of sold price to consignor.
- There is NO time limit for consignment on Jewelry, Crystal, China, Silver or Artwork.
- **Clothing** is consigned for 60 days. After thirty (30) days JUST LIKE NEW will reduce unsold, **clothing** by twenty-five percent (25%).
- If after sixty (60) days, the clothing is still not sold and you choose to pick up your unsold **clothing**, they MUST be picked up within seven (7) days after. Or, if you so choose (see below *) the consignor may give Just Like New instructions to donate the unsold items. If the **unsold clothing** is NOT picked up nor donation instruction given – the items become the property of Just Like New.
- It is the consignor’s responsibility to track the dates of expiry for consignments and sales status.
- Clothing, handbags and shoes must be seasonal and will be accepted as follows. Spring items will be taken February to April, Summer items from May to July, Fall items from August to October and Winter items in November and December.
- Merchandise MUST be current, in style (2 years or less), with designer labels and in excellent condition. All clothing must be on hangars, dry cleaned and or freshly laundered, pressed with **NO** alterations, holes, stains, tears, missing buttons, zipper issues, worn collars or cuffs etc...Please inspect the items before bringing to consign.
- On our website there is a list of designer labels that we accept. This however is not an all inclusive list as we have many people bring us high quality European labels.

2. Payments to consignor:

- Payments for sold items will be made to consignor after the 60 days has lapsed from the date the item was consigned. Payment days are on Thursdays and we ask that you call us if you are coming to pick up a payment at least a couple of days prior. At the instruction of the consignor the payment/check may also be mailed by USPS.
- **It is the consignor’s responsibility to track the dates for payment.**

3. Although we take great measures in taking the best care for your items as we have excellent security systems, cameras and monitoring equipment against shrinkage - all items are left at the consignor’s risk. Just Like New2,LLC and their employees are not responsible for damaged, lost, stolen or missing articles at any time. The consignor Holds Harmless, Just Like New2,LLC for any and all losses at any time.
